PUBLIC NOTICE

In accordance with the provisions of the Wyoming Environmental Quality Act and Chapter 1, Section 2(j) of the Solid Waste Rules and Regulations (SWRR), the Upper Platte River Solid Waste Disposal District has submitted a SWRR Chapter 6 low hazard and low volume (LH/ LV) permit application for a new solid waste management facility called the Saratoga LH/LV Municipal Solid Waste Transfer

The approximate 5-acre proposed facility is located 1.6 miles east of the Town of Saratoga, Wyoming. More specifically, this facility is located in the SE1/4, SW1/4 of Section 8, Township 17 North, Range 83 West Sixth Principal Meridian, Carbon County, Wyoming. The proposed facility will provide for the transfer of municipal solid waste which is generated within the Town of Saratoga, Encampment, Riverside, unincorporated communities of Walcott and Ryan Park and surrounding rural communities. The estimated daily acceptance rate is 50 cubic vards or less per day. The total volumetric storage capacity of this facility is estimated to be 150 cubic yards. The life of this facility is indefinite.

The Department of Environmental Quality, Solid and Hazardous Waste Division (Department) has reviewed the new permit application and determined that it is generally complete and suitable for publication. The Department's SWRR, in Chapter 1, Section 2 (j)(iii)(A), require that the applicant must provide public notice that a proposed permit has been issued, and inform the public that there is an opportunity to file comments on the proposed permit before it is issued in final form. The notice is also required to indicate that the public may file formal written objections to issuance of a final permit. This publication provides notice of those opportunities.

Copies of the new permit application, the Department's review of the application, and the proposed permit can be viewed at the Department's Cheyenne office located at 200 W. 17th Street, 2nd Floor, Cheyenne, Wyoming, 82002.

Any interested person has the right to either: provide comments on the proposed permit, which the Department will consider prior to taking final action on the permit application, or file formal written objections to the proposed permit. The period for providing comments, or filing formal written objections to the

proposed permit, shall begin on Wednesday, March 16, 2016 and end on Friday, April 22, 2016. Any comments or formal written objections must be received by 5:00 PM on the last day of the notice period. Comments or formal objections must be submitted in writing to the Department of Environmental Quality, Todd Parfitt, Director, 200 W. 17th Street, Cheyenne, Wyoming, 82002. Formal written objections must be accompanied by a statement of the facts upon which the objection is based. If substantial written objections are filed, a contested case hearing will be held by the Environmental Quality Council.
