SARATOGA TOWN COUNCIL REGULAR MEETING MINUTES APRIL 6, 2021 AT 6:00 P.M. SARATOGA TOWN HALL COUNCIL CHAMBERS

Mayor Creed James called the meeting to order at 6:00

Members present were: Councilman Bob Keel, Councilwoman D'Ron Campbell and Councilman Ben Spaulding were present. Councilman Jon Nelson was called in on conference call.

APPROVAL OF THE AGENDA

Councilwoman Campbell made a motion to approve the agenda of the April 6, 2021 Saratoga Council Meeting. Councilman Keel seconded; motion carried.

**APPROVAL OF THE MINUTES** 

Councilman Spaulding made a motion to approve the minutes of the March 16, 2021 meeting. Councilwoman Campbell seconded; motion carried. **APPROVAL OF THE BILLS** 

Treasurer Flohr read the Accounts Payable, Payroll and Transmittal bills as follows:

Net Payroll 4/6/2021\$28,842.08 Transmittals 4/6/2021 \$ 17,207.83

Councilman Spaulding made a motion to pay the accounts payable for 4/6/2021 in the amount of \$75,370.62. Councilman Keel seconded; the motion carried Councilman Keel made a motion to pay the net payroll

for 4/6/2021 in the amount of \$28,842.08. Councilman Spaulding seconded; the motion carried. Councilman Spaulding made a motion to pay the 4/6/2021 Transmittals in the amount of \$17,207.83. Councilwoman

Campbell seconded, the motion carried. **CORRESPONDENCE** 

The Wyoming Children's Trust Fund mission is "Coordinating prevention efforts in Wyoming to prevent incidents of child neglect, emotional, physical and sexual abuse". April was first declared Child Abuse Prevention Month by presidential proclamation in 1983. The Town of Saratoga Mayor Creed James will proclaim the month of April 2021, "Child Abuse Prevention Month (CAP). Councilwoman Campbell made a motion; Councilman Keel seconded, motion carried.

**COUNCIL COMMENTS** 

Councilman Keel read his resignation letter April 6, 2021 and resigned from his position from the Saratoga Town Council. Councilman Spaulding and Mayor James thanked Councilman Keel for his time commitment to town. Councilman Keel left the council chambers. Mayor James declared a vacancy which expires December 2022, and Councilman Spaulding made a motion to advertise an open council seat to be filled. Councilwoman Campbell seconded. The letter of interest would need to be delivered to town by April 16, 2021. The letters would need to be addressed at the next council meeting on April 20th. Motion carried.

**ITEMS FROM THE PUBLIC** 

Candice Fritz from Carbon County Road and Bridge and Carbon County Commissioner Sue Jones are present to speak about doing a joint project to do a chip seal overlay along conjoining roads in 2022. Mayor James has spoken with Sue Jones about the project before and agrees it will be good for the town and will discuss further after budget planning. Carbon County will need to look at budgets as well and wants to work jointly to offset the cost from doing the project alone. Candice Fritz mentions that the average chip seal overlay was \$50,000-\$75,000 per mile and the timeline for the road would be the next year 2022 since their fiscal year starts July 1st. Candice has applied for grants but was not successful and she says that funding is decreasing for this. The Cemetery Board is interested in having the chip seal done to their road as well and mentions the adjoining landowners to

join in because of the heavy equipment that they drive over the roads. The Landfill Board is interested in the chip seal overlay as well. Commissioner Jones says that it can be a reasonable project if all interested parties can coordinate. Councilman Spaulding asked Jon Winter of Saratoga Public Works if we have other roads that need chip seal. Winter said the last chip seal overlay in town was in 2016. Councilman Spaulding asked Winter to get a priority list on roads that need a chip seal. Candice Fritz will ask Craig Kopasz of Engineering Associates for an engineering estimate to start looking at numbers and will email the Mayor and council members moving forward. REPORTS FROM DEPARTMENTS

Town Hall: Mayor James swore in newly appointed Town Clerk, Marie Christen, with the Oath of Office on April 6, 2021.

Councilwoman Campbell made a motion to update bank cards and put Marie Christen on signature cards. Councilman Spaulding seconded; motion carried.

Every year, the Town of Saratoga purchases a wellness contract for employees to have bloodwork done for free to the employee at the Wyoming Health Fair at a rate of \$40 per participant. Councilman Spaulding made a motion to approve the contract, Councilwoman Campbell seconded the motion; motion carried.

Mayor James spoke to accountant, Stuart Webster, regarding the Town's audit and Stuart is busy with family issues. Carver, Florek & James CPAs will not go forward for an audit for the town. Mayor James will reach out to 2 other firms for a 2019-2020 audit.

Police Department: Chief Lehr had no new updates. Fire Department: The Fire Department received their new bunker gear and has been updating their equipment since 2 years ago because their equipment was out of compliance. The Town of Saratoga donated fire boots to all the volunteers and the Fire Department has held various fundraising and have been able to update all of their gear. Mayor James mentioned the Fire Department would not have been able to do this without generous community support and thanked the Town of Saratoga.

Recreation Dept: Ball Fields: Mayor James spoke to the Director of Department of Public Works, Jon Winter, about a long term lease with the Woods family and what that entailed. The Woods family would like water to their residence in exchange for the Town of Saratoga using their property for a baseball field. Mayor James said that Engineering Associates engineer, Craig Kopasz, will volunteer his time to put in an application to DEQ. The Town of Saratoga will divert their attention from the ball fields they own because of a gopher problem and will devote their attention to Woods Field because of the family being so supportive of the Little League. The Town of Saratoga will install water to the residence in exchange for a long-term lease. Jon Winter has received quotes on a sprinkler system and said Woods Field would be easy to expand in the future for a restroom and snack bar at a later date. Mayor James said they will keep working and see what the total cost is for the town for figures and work on funding.

Gym: The report from the Recreation Director is attached to these minutes. The gym and weight room have continued to be open and has added evening hours as well. They are still offering the same classes and may add several activities for the Summer. They are still 2 board members short and the next meeting is Monday, May 3rd at 6pm. The pool will be open Memorial Day weekend. Recreation Director, Lisa Burton, asked permission to advertise for summer pool help. Councilwoman Campbell made a motion to advertise, Councilman Spaulding seconded: motion carried.

Department of Public Works: Water & Sewer: Director of Public Works, Jon Winter, requested to purchase a pallet of pothole patch for \$867.50. Councilman Spaulding made a motion and Councilman Nelson seconded. Councilwoman Campbell asked if there was enough in the budget to cover this and Winter said the Town has only used 21% of the allocated budget. Motion carried. Winter also discussed patch work, snow removal, sanding, plowing and the usual work. The department has replaced 9 street signs because of the high winds. Winter will develop an inventory list of signs to order one of each to replace right away to prevent delay.

Emergency Manager, Lenny Layman, requested our assistance in doing a dry run on a new sandbagging implement purchased by Carbon County. This dry run will be scheduled in the next two weeks depending on the weather. Layman asked the County Attorney for a MOU for use of equipment and will start trying out new sandbag machine to see how it works.

Winter said the last CO2 cylinder were put in at lagoon. Winter asked to purchase 3 – 150lbs cylinders for CO2 gas for \$1,624.00 because the last purchase was in November 2020. Councilwoman Campbell made a motion. Councilman Nelson seconded; motion carried. The department has received the louver/damper this week

for the standby generator in Wellfield building #3. Winter is working with the Town of Saratoga's new electrician to do tie in work on the standby generator. The SCADA upgrade is scheduled for mid-May. Winter had been discussing BOD values with the Ag lab in Laramie and they requested to give them time for them to analyze their processes and procedures. The Ag lab have not found out why the town's BOD levels were higher than the data. They are working with the DEQ lab and we will send in a split sample to DEQ labs and see if there is any variation. Director Winter has updated Ordinance 13.06.010 and 13.60.020. He found the ordinances contradicted each other and provided to the other members of Town Hall to review and comment. Winter is also working on the wording on the Town's delinquency notice to reflect draft

ordinance changes. Winter is receiving quotes from companies to replace the air vent atop the welded standpipe and revised costs to repair the bolted tank. He spoke with Councilman Nelson and received a quote the Town received 2 years ago and contacted the company for new numbers. This quote will be brought to the Water & Sewer Joint Powers Board next week and we will receive an update at the next council meeting.

Weed and Pest: Winter requests permission to order \$12,936.75 of mosquito adulticide and larvacide. Carbon County Weed and Pest has a grant that usually covers most of the cost, but we will need to purchase this during this fiscal year and receive reimbursement for the next fiscal year. Winter says his department chemical line item budget has spent \$14,000 out of \$15,000 and the budget for pests is only at 36% fulfilled. Councilman Nelson said a budget amendment will be necessary to purchase 2 years' worth of product for 1 fiscal year. Councilman Nelson made a motion for a budget amendment of \$12,936.75 for product to be purchased this year with reimbursement next year. Councilwoman Campbell seconded the motion. Councilman Nelson wants to ensure the reimbursement comes in and that it gets tracked so that we do not take out of the general fund. The motion carried. Winter submitted a grant to the WY Department of Ag in the amount of \$28,296.60 of which grant funds awarded would not be more than \$12,921.85. Last year, the town was awarded \$10,000 in grant money.

Hot Pools: Hot pools were cleaned on April 1st. Someone had a diesel spill in the parking lot of hot pools and the town cleaned it up.

Parks: Director Winter requested funds for annual fertilizer for the parks at a total of \$1,438.80. This total includes Woods Field. Councilman Spaulding spoke with Deb Arnold and she will donate the cost of the fertilizer and installation of it for Woods Field. Councilwoman Campbell made a motion to approve the funds for the fertilizer;

Councilman Spaulding seconded; motion carried.
Councilman Nelson asked Winter if he had responded to County Emergency Manager, Lenny Layman, about the number of sandbags that were in town. Winters responded that he had, and the Town of Saratoga currently has 65,000 bags in town.

Community Center Joint Powers Board: Councilman

Keel was on the board but has resigned. Councilwoman Campbell will attend the next meeting on April 12, 2021

Water and Sewer Joint Powers Board: Director Winter spoke about updating the delinquency notice previously. Councilman Nelson said he received an email from WLC about the plat and did not realize Jajaca Easement was on it. He will confirm that it is on there and if it is, there is nothing else to follow up on. Next Water and Sewer Joint Powers Board Meeting is April 14, 2021 at 6:00 p.m. at

**Planning Commission:** The next meeting for the Planning and Zoning Commission is April 13, 2021 at 5:30 p.m. in the Council Chambers.

Saratoga Airport Advisory Board: Councilwoman Campbell said the board will need to address bids and meet deadlines for apron expansion. Next quarterly meeting has been rescheduled for April 7, 2021 at 10 a.m. at Council Chambers of Town Hall.

SCWEMS Board: SCWEMS is requesting reimbursement

of \$55,334.75 for the Saratoga Ambulance Barn Addition. The Town of Saratoga received \$150,000 from the 2019 Specific Purpose Tax for this purpose. Councilman Nelson wants the reimbursements tracked so that it does not exceed \$150,000. Councilwoman Campbell made a motion to reimburse SCWEMS, Councilman Spaulding seconded. Motion carried. The next meeting for SCWEMS is April 19, 2021 at 6pm at the Saratoga Ambulance Barn. **NEW BUSINESS** 

Councilman Spaulding said Tyler Pickett Park was mentioned at the last council meeting. He was asked to oversee it. Councilman Spaulding is meeting with Chuck Bartlett for discussions on this project, and see if we can get military sponsorships to assist with the cost of the park. Councilman Spaulding wants to create an informal committee and receive input on it to honor Tyler Pickett and his family.

**EXECUTIVE SESSION** 

To discuss personnel and matters of litigation in accordance with W.S. 16-4-405(a)(ii) and (iii)

Councilman Spaulding made a motion to enter executive session. Councilwoman Campbell seconded; motion carried. Councilwoman Campbell made a motion to exit executive session. Councilman Spaulding seconded;

**FURTHER BUSINESS** No further business. **ADJOURNMENT** 

There being no additional business to come before the council, Councilman Spaulding made a motion to adjourn at 7:46 p.m., Councilman Nelson seconded, and the motion carried.

The pre-bid is not mandatory but contractors are strongly encouraged to attend.

No bids will be received after the above specified hour and date, and bids which are not prepared and filed in accordance with proposal requirements and conditions of the specifications may be rejected. The Owner further reserves the right to reject any and all bids and to waive irregularities.

#### The work is generally described as:

Pavement removal, grading, drainage, crushed base, bituminous plant mix and concrete paving, pavement marking, medium-intensity taxiway lighting, guidance sign installation, treated water main installation, apron lighting, and reclamation.

#### PROPOSED DISCHARGE OF DREDGED OR FILL MATERIAL TO THE NORTH PLATTE RIVER

The Wyoming Department of Environmental Quality (WDEQ) has received a request from the Wyoming Game and Fish Department for State certification of U.S. Army Corps of Engineers (USACE) Nationwide Permits #27 and #42, for discharge of dredged or fill material to the North Platte River near Saratoga, Wyoming. The purpose of the project is to stabilize banks and enhance habitat through restoration of channel function along with improvements to boating access and parking facilities at the Treasure Island public access area. This segment of the North Platte River is designated a Class 1 water where point source discharges are prohibited except for storm water and construction related discharges. This certification will require meeting the provisions in Chapter 1, Section 7(b) of the WDEQ Water Quality Rules and Regulations, which allows these discharges under certain circumstances.

Proposed activities would result in permanent placement of approximately 4,250 cubic yards of fill that will impact 0.18 acre of wetland. Compensatory wetland mitigation will be required.
