PROPOSED AMENDMENTS, INITIATIVES, REFERENDUMS AND BALLOT PROPOSITIONS

CONSTITUTIONAL AMENDMENT A

The adoption of this amendment would separate residential real property into its own class of property for purposes of property tax assessments. The amendment would authorize the legislature to create a subclass of owner occupied primary residences.

Shall the additional special school district levy in the amount of one-half (1/2) mill upon each dollar of assessed valuation within Carbon County School District One (not to exceed two (2) mills) be continued for the maintenance of post secondary education services offered by the Carbon County Board of Cooperative Higher Educational Service?"

PROPOSED FORMATION OF A SPECIAL HOSPITAL DISTRICT AND FIVE (5) INITIAL DISTRICT DIRECTORS

"Formation of a Special Hospital District within Carbon County - Shall the proposed special hospital district within Carbon County be established to operate pursuant to Wyo. Stat. Ann. § 35-2-401 through 438 to be funded by a tax levy upon taxable property within the district not to exceed three (3) mills?"

VOTING ASSISTANCE

Any elector who requires assistance to vote because of blindness, disability, or inability to read or write, may be given assistance by a person of the elector's choice, other than the elector's employer or an agent of that employer or an officer or agent of the elector's

union (W.S. 22-13-113 (a)). There will be an accessible ballot marking device (Express Vote) available at every polling place. THE FOLLOWING ARE CAMPAIGN REPORTING REQUIREMENTS:

W.S. 22-25-106 a) Except as otherwise provided in subsections (g) and (j) of this section and in addition to other reports required by this subsection: (i) Every candidate, whether successful or not, shall file an itemized statement of contributions and expenditures at least seven (7) days but not more than fourteen (14) days before any primary, general or special election. Any contribution received or expenditure made after the statement has been filed, through the day of the election, whether a primary, general or special election, shall be filed as an amendment to the statement within ten (10) days after the election (a) Any person required to file a report under W.S. 22-25-106 shall be given notice prior to an election, by the appropriate filing office specified under W.S. 22-25-107, that failure to file the report within the time required by that section shall subject the person to civil penalties as provided in subsection (f) of this section. The notice shall inform any candidate's campaign committee, organization, political party or political action committee that the officers responsible for filing the report shall be subject to the same civil penalties as the candidate's campaign committee, organization, political party or political action committee for failure to file the report. (b) Any person who fails to file a report under W.S. 22-25-106 within the time required by that section shall have their name printed on a list drafted by the appropriate filing office. The filing office shall: (i) Immediately post the list in the filing office and make the list available to the public; (ii) Notify the person at their address of record that the person has twenty-one (21) days from the date the notice was sent to comply with W.S. 22-25-106 or be subject to civil penalties as provided in subsection (f) of this section. (f) The appropriate filing office or the county attorney, for reports required to be filed with the county clerk, shall issue a final order imposing the civil penalty specified in this subsection against any person failing to comply with W.S. 22-25-106 twenty-one (21) days from the date the notice was sent under subsection (b) of this section. The final order shall be sent to the person at their address of record and shall notify the person of the right to request reconsideration of the order as provided in subsection (h) of this section. The filing office or county attorney shall impose the following civil penalty in the final order after giving due consideration to the willfulness of the failure to file, the person's level of experience with reporting requirements under this act, efforts made to obscure the identity of the person required to file and any other factor evidencing an intent to evade reporting requirements under this act: (i) Up to five hundred dollars (\$500.00) per day beginning on the date of the final order and ending when the report is filed for a failure to file a report with the secretary of state; (ii) Up to two hundred dollars (\$200.00) per day beginning on the date of the final order and ending when the report is filed for a failure to file a report with the county clerk. W.S. 22-25-109 Reporting candidates in violation. The secretary of state and the county clerks shall report the names of all candidates in violation of the Election Code of the state of Wyoming to the attorney general or to the district attorney, respectively, for appropriate action.

Box 6, Rawlins, WY 82301, by emailing elections@carboncountywy.gov or by calling 1-307-328-2650 or toll free at 1-800-250-9812. If requesting an absentee ballot in writing please include your full legal name, your physical address, the address you want the ballot mailed to, your date of birth, party affiliation, and a contact number where you can be reached. Absentee ballots will be available 28 days prior to each election.
