Commissioner Moore seconded and the motion passed unanimously. Commissioners

Commissioner Jones moved to approve the Agreement for Transfer of Entitlements from Rawlins Municipal Airport/Harvey's Field to Dixon Airport in the amount of \$68,000.00 for Fiscal Year 2021. Commissioner Barkhurst and the motion passed unanimously. 2022-2023 COMMISSIONERS' SCHOLARSHIPS

Commissioner Espy moved to award County Commissioner's Scholarships as follows: Jaden Campbell from Saratoga, Garrett Parker from Rawlins, and Rainey Wilson from Hanna. The alternate scholarship recipients are Geoffrey Johnson from Saratoga, Elijah Longog from Rawlins, and Jessie Jerome from Rawlins. Commissioner Barkhurst seconded and the motion carried unanimously.

Commissioner Espy moved to award the County Commissioner's renewal scholarship to Siobhan Lally. Commissioner Barkhurst seconded and the motion carried unanimously.

#### EXECUTIVE SESSION

Commissioner Espy moved to go into executive session at 2:46 p.m. with Clerk Bartlett and Ashley Mayfield Davis to discuss personnel, potential litigation and other matters considered confidential by law. Commissioner Moore seconded and the motion carried unanimously.

Commissioner Espy moved to come out of executive session at 3:21p.m. noting no action was taken and that the minutes be signed and sealed. Commissioner Moore seconded and the motion carried unanimously. <u>Public Hearing - C.U.W. Case #2022-01 - PacifiCorp - Rock River I</u> Wind Energy

Chairman Johnson opened a public hearing at 3:22 p.m. to hear Planning & Zoning Case C.U.W. Case #2022-01 - PacifiCorp - Rock River I Wind Energy - PacifiCorp's request for a Conditional Use Permit for a Commercial Wind Energy Facility in the Ranching, Agriculture and Mining (RAM) Zone. The request is to allow the applicant (PacifiCorp) to repower the "Rock River I Wind Energy Project" (Project). Currently the Project consists of 50 wind turbines and pad sites. The applicant plans to replace the 50 wind turbines with 19 new turbines. The overall Project installed nameplate capacity will increase from 50 MW to 53.58 MW. However, the total Project capacity interconnected to the transmission system will remain unchanged at 50 MW. Repowering activities will es of temporary construction The Project includes all associated components and facilities that are necessary to generate electricity and deliver electricity to the transmission grid. The existing O&M/control building, maintenance yard(s), staging vard(s), storage area(s), substations and related facilities and equipment are expected to remain unchanged and located in the Eastern portion of Carbon County; primarily to the northeast of I-80, north of State Highway 13, and east of Carbon County Road #1 (Medicine Bow-McFadden Road). Sarah Brugger, County Planning Director presented the case file. There being no other comments, Chairman Johnson closed the hearing at 3:38 p.m. Commissioner Barkhurst moved that based on the recommendation of the Planning & Zoning Commission and staff to approve Resolution No. 2022-21, A Resolution of the Board of County Commissioners of Carbon County, Wyoming adopting the recommendation of the Carbon County Planning and Zoning Commission regarding C.U.W. Case #2022-01 - Rock River I Wind Energy - PacifiCorp's request for a Conditional Use Permit for a Commercial Wind Energy Facility in the Ranching, Agriculture and Mining (RAM) Zone. The request is to allow the applicant (PacifiCorp) to repower the "Rock River I Wind Energy Project" (Project). Located in the Eastern portion of Carbon County; primarily to the northeast of I-80, north of State Highway 13, and east of Carbon County Road #1 (Medicine Bow-McFadden Road), with conditions as presented. Commissioner Jones seconded. Commissioner Jones discussed the sales tax being paid out of state noting this has occurred numerous times on various projects. She requested a solution for this issue prior to moving forward. Commissioner Barkhurst would like a solution as well and Chairman Johnson stated he feels Condition 15 should be kept and amended slightly where if the funds do not fall into a use tax, then the mitigation or impact payment would be equivalent to the total sales tax due to the county. Attorney Davis read a proposed

condition regarding the matter "Point of Sale for all construction materials utilized in this Conditional Use Permit shall be Carbon County, Wyoming. For any construction materials used that cannot comply with this condition, the Owner(s), Operator(s) or Subcontractor(s) shall provide documentation to the State of Wyoming, Department of Revenue, to determine whether a Use Tax shall apply. This documentation and any determination by the Department of Revenue shall be provided to the Carbon County Clerk within 30 days of such determination. If sales and use tax do not apply, Applicant shall provide an impact assessment payment equivalent to 6 percent of the purchase price of such construction materials, which shall be distributed by the Carbon County Treasurer to the State of Wyoming and all applicable taxing entities. The Owner(s) or Operator(s) shall provide the County Treasurer with receipt(s) that include the purchase price of said construction materials and assessed payment shall be paid to the County Treasurer as certified funds within 150 days of such materials being used on the project." Mr. Hemstreet proposed that rather than 6% they would only pay the portion the county would receive. Commissioner Barkhurst stated concern for this solution as he cannot wrap his head around what the county needs to do to solve this issue. There was discussion of tabling the case until a more palatable solution could be finalized. Mr. Hemstreet stated a 45-60day tabling would not affect their project timeline. Commissioner Moore asked the applicant the best remedy for this and other projects as this issue keeps arising with various projects. Commissioner Barkhurst moved to table this motion and public hearing until June 7 at after completion of other planning hearings which begin at 1:30 p.m. Commissioner Jones seconded and the motion carried unanimously.

#### Public Hearing - C.U. Case #2022-02-Linkville Land Holdings -Simpson Ridge Green Hydrogen Project

The Project will have a hydrogen and oxygen production facility along with a hydrogen fueling station. The Project will convert renewable energy into green hydrogen and high purity green oxygen. The hydrogen will be marketed as a replacement for natural gas, propane, and other carbonbased energy carriers. This project will be located East of Elk Mountain at Exit 260 and I-80; west side of Carbon County Road #3. Sarah Brugger, County Planning Director presented the case file. She noted her office received a petition to deny the project containing approximately 30 signatures in addition to numerous other comments requesting denial and others of support. Ms. Bruggar overviewed review criteria. She discussed staff recommendations noting the Planning & Zoning Commission approved these for recommendation to the BOCC.

Chairman Johnson called for comments for or against the case. There being no further comments, Chairman Johnson closed the hearing at 6:04 p.m.

Commissioner Moore moved that based on the recommendation of the Planning & Zoning Commission and staff to approve Resolution No. 2022-22, A Resolution of the Board of County Commissioners of Carbon County, Wyoming adopting the recommendation of the Carbon County Planning and Zoning Commission regarding C.U. Case #2022-02 -Simpson Ridge Green Hydrogen Project", Linkville Land Holdings, LLC and Tetrad Corporation's request for a Conditional Use Permit in the RAM Zone to construct, operate, and maintain the Simpson Ridge Green Hydrogen Project (Project). This project will be located East of Elk Mountain at Exit 260 and I-80; west side of Carbon County Road #3. Commissioner Jones seconded. Chairman Johnson expressed concern with the narrative changing based on the audience. He added that the company is stating this is a grandfathered permit when it really isn't. He added that the application was poor and that the socioeconomic report had misinformation in it, yet they say they care about the county and Wyoming but failed to do their research. Commissioner Espy reported he did receive a call from Mr. McKay at the Governor's Office stating they are watching the case at this time and at this time does not support nor oppose the project although the company appeared to be representing the Governor is in favor. He stated that he will never support development in a core sage grouse area, which is where the project is proposed for. Commissioner Jones discussed the 7 land use goals in the Land Use Plan and discussed her concerns regarding each of those related to this application. She discussed her concern for the various companies involved in the project owned by the two applicants. She added her concern for the water use by the facility and thought the idea is good, but the location was a poor choice. Commissioner Barkhurst commended the group on their forward thinking. He discussed labor concerns and the difficulties finding help and that he doesn't feel the project is quite ready to move forward at this time. Commissioner Moore didn't feel the
