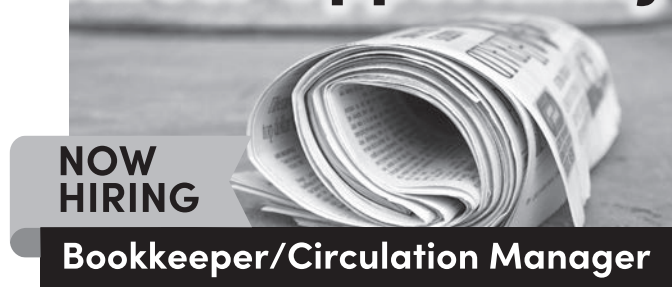

## REFLECTIONS FROM OUR FILES

**September 18, 1924 100 Years Ago**

### Floyd Moore Arrested for Passing Bad Checks

Jailed in Denver Last Week fr Crime Committed There Four Years Or More Ago. Last Wednesday's Den-

ver Post stated that Floyd Moore, for several months past employed at the Tilton Land & Live Stock Co. ranch up the river, had been ar-

rested by Denver detectives the day before and was held in the city jail there on a charge of obtaining money on two fraudulent checks,

which he had passed in the city about four years ago. His likeness had been on file in the Denver rogue's gallery and when he appeared on

the Denver streets last week he was recognized and incarcerated.

Since his residence in this valley it has been rumored at

times that he wrote checks freely without regard to the state of his bank balance, but no prosecution had resulted.

**September 22, 1949 75 Years Ago**

### New Traffic Signals Arrive, and Will Be Installed Soon

The new traffic stop light and two caution lights for Saratoga, which had been on order for some time, arrived the first of this week, and will be installed as quickly as possible, according to town officials.

The red stop light will be placed in the intersection at Bridge and First streets, it has been announced, and when in operation it will stop cars and pedestrians from all directions for intervals of about 30 seconds. The light was deemed necessary by the town council

owing to the tendency of many vehicle drivers to proceed too fast along First street, which with the completion of the new bridge and highway, has also been designated as Highway 130 through Saratoga. It is expected the light will at least in part solve this problem by regulating the traffic through the intersection.

The two caution lights, as a warning to drivers to slow up on entering town, will be placed at each end of First street. One will be placed at the intersection on First

street just south of the bridge approach, near the John Glode home, and the other will be placed at the intersection of First street at the south end of town a short distance from the cut near the Paul Holmes residence.

The town officials also announced four school zone signs have been erected, and that stop signs are up at all intersections along First street. Also safety zones are being designated for the benefit of children crossing First street to and from school, and all

parents are urged to encourage their children to observe these zones.

The council is especially urging parents to encourage their children to use care with bicycles, and warns that children on bicycles are subject to the same rules and regulations as the drivers of motor vehicles.

Included in these regulations is the requirement that a suitable light be installed on all bicycles being used at night, that bicycle riders observe all stop signs and

lights and cautions signs and that cyclists, especially along Bridge and First streets, ride in a straight line and do no "wobbly" riding and that U-turns, riding the wrong side of the street, and other dangerous practices be avoided. Several near accidents have been observed as result of careless use of bicycles by local children, and the council is anxious to stop such carelessness before some child is seriously injured or perhaps killed. One particularly dangerous

practice which has been observed several times is boys riding tandem, their bicycles tied together with a 15- or 20-foot length of small rope. Should a car try to go between the bicycles, especially in the evening when the small rope is difficult to see, very serious injuries might be the result.

The Council has also warned that as soon as all lights and signs have been installed, the business section of the town is to be patrolled and all traffic rules and regulations enforced.

**September 19, 1974 50 Years Ago**

### Accident Time in Saratoga

Two vehicle mishaps were reported in Saratoga last Thursday. The first was when two driverless cars collided on Bridge street about 7 a.m. in front of the Sisson Hotel. The second

involved vehicles driven by Mrs. Mildred W. Dickinson and Mike Barnette and happened near the Sand Restaurant about 3:45 p.m.

According to the investigating officer, a U.S. Fish

& Wildlife Service vehicle assigned to Avon Bruce McElwain of Fort Morgan, Colo., backed into a parked vehicle belonging to Dan A. Seger of Cheyenne. Mr. McElwain was letting the station wag-

on warm-up while he was in Pickett's Pantry for breakfast. Somehow it dropped into reverse and backed into the Seger vehicle. No state reports were filed and no estimate of damage was released.

In the second accident, nearly \$700 worth of damage was done to the two vehicles. Mrs. Dickinson was driving south of Highway 130 when her vehicle collided with a car being driven by Mr. Barnette

who was pulling out of the driveway behind the Sand Restaurant. No citations were issued, but the state reports were filed.

No injuries were reported in either mishap.
