INSURANCE | MEDICARE OPEN ENROLLMENT BEGINS OCTOBER 15, 2024



It is time to review your Medicare plans and Part D Coverage. Every year you should check your Part D prescription coverage to see if any plan changes are necessary. In addition, there are some changes in 2025 that you may be interested in knowing.

Part D Drug Expenses: In 2025, if you have Part D your yearly out-of-pocket drug costs will be capped at \$2,000. Starting in 2025 you will also have the option of spreading your drug costs across monthly payments throughout the year.

Mental Health and wellbeing: Medicare covers expanded mental health care. For instance, intensive outpatient program services in certain locations and services from marriage and family therapists and mental health counselors. During a wellness visit your health care provider can also use a health risk assessment to better understand your social needs and refer you for appropriate services and support.

Caregiver Support: Medicare covers additional caregiver support, like training that helps your caregiver better care for you and relief when they're caring for family members in hospice care. Also, some people living with dementia and their caregivers may be able to get more support though a new pilot program.

Changes to Telehealth: You can get telehealth services at any location in the U.S., including your home, through December 31, 2024. After this period, you must be in an office or medical facility located in a rural area for most telehealth services. However, you can still get certain telehealth services (like for mental and behavioral health) in your home no matter where you live.

Medicare v. Medicare Advantage: You may have watched a few commercials regarding Medicare Advantage. The following breaks down some of the differences. Most important to note is

doctor hospital choice. Verify with your provider that they accept Medicare Advantage.

Doctor and Hospital choice:

Original Medicare: You can use any doctor or hospital that takes Medicare, anywhere in the U.S. In most cases, you don't need a referral to use a specialist. Medicare Advantage (Part C): In many cases, you can only use doctors and other providers who are in the plan's network and service area (for non-emergency care). Some plans offer non-emergency coverage out of network, but typically at a higher cost. You may need to get a referral to use a specialist.

Costs:

Original Medicare: For Part B-covered services, you usually pay 20% of the Medicare approved amount after you meet your deductible. This amount is called your coinsurance. You pay the monthly premium for Part B. If you choose to join a Medicare drug plan, you'll pay a separate premium for your Medicare drug coverage (Part D). There's no yearly limit on what you pay out of pocket, unless you have supplemental coverage—like Medicare Supplement Insurance (Medigap), Medicaid, employer, retiree, or union coverage. You can choose to buy Medigap to help pay your out-of-pocket costs that Medicare doesn't cover (like your 20% coinsurance), or you can use coverage from a current or former employer or union, or Medicaid.

Medicare Advantage: Out-of-pocket costs vary. Plans may have different out-of-pocket costs for certain services. You pay the monthly Part B premium and may also have to pay the plan's premium. Some plans may have a \$0 premium and may help pay all or part

of your Part B premium. Most plans include Medicare drug coverage (Part D). Plans have a yearly limit on what you pay for covered Part A and Part B services (with different limits for in-network and out-of-network services). Once you reach your plan's limit, you'll pay nothing for covered services for the rest of the year. You can't buy Medigap to cover your out-of-pocket costs.

Coverage:

Original Medicare: covers most medically necessary services and supplies in hospitals, doctors' offices, and other health care facilities. Original Medicare doesn't cover some services, like routine physical exams, eye exams, and most dental care. In most cases, you don't need approval (prior authorization) to cover your services or supplies. You can join a separate Medicare drug plan to get Medicare drug coverage (Part D).

Medicare Advantage: For some services, plans may use their own coverage criteria to determine medical necessity. Plans may also offer some extra benefits that Original Medicare doesn't cover. In many cases, you may need to get approval (prior authorization) from your plan before it covers certain services or supplies Medicare drug coverage (Part D) is included with most plans. In most types of Medicare Advantage Plans, you can't join a separate Medicare drug
